## THE COMPANIES ACT, 2013 (COMPANY LIMITED BY SHARES) MEMORANDUM OF ASSOCIATION

OF

#### RDB INFRASTRUCTURE AND POWER LIMITED

- 1. The Name of the Company is RDB INFRASTRUCTURE AND POWER LIMITED.
- The Registered Office of the Company will be situated in the State of Haryana<sup>(1)</sup>.

- III. The objects for which the Company is established are:

### [A] MAIN OBJECTS TO PURSUED BY THE COMPANY ON ITS INCORPORATION ARE:

- To develop and promote fully integrated and comprehensive residential, market, business and shopping complex with all facilities and to rent, lease, sale and do whatsoever business as may deem fit for the company.
- To carry on business of setting up and running a warehousing hub, bus terminus, residential complex and all other works either independently or in joint venture with Government or Semi-Government or any collaboration with any authority.
- 3. To carry on the business of development of infrastructure facilities for multilevel vehicle parking terminals such as cars, trucks, and buses and for the purpose to build, erect, construct, develop, maintain, operate, buy, sale, lease or hire all kinds of Infrastructure facilities including spaces of parking halting, garaging, loading, unloading, fuelling, godowning, warehousing and weighment as may be required from time to time and to carry on the business to set up a warehousing hub, colony with Multifarious facilities either independently or in joint venture with Government or semi-Government of collaboration with any authority.
- 4. To set up, establish, develop infrastructure for Warehousing/Logistic Hub, Transport Terminal, erect, promote, undertake, acquire by purchase, lease, hire or otherwise own lease, operate, maintain, renovate and to run Transport Terminals and Warehousing/logistic Hub or such other establishments by whatever name called, in any part of India and to provide, construction of roads, Lanes and parking of trucks, buses or any other type of vehicle by whatever name called to provide service of loading and unloading or other services which can be rendered while running and operating each terminals, to establish and run toll gate, to establish and run Fuel Station to provide petrol, diesel, kerosene, gas or any type of inflammable material, liquid and lubricants or other such things which are generally provided at fuel station and for this purpose to act as buyer, seller, trader, dealer, contractor, agent or deal in any manner whatsoever in petrol and such other goods, to construct establish, maintain and operate shops where tire, rubber and every kind of description of auto parts and accessories can be traded and for this purpose to act as buyer, seller, trader, dealer, agent, etc. tires, rubber, auto parts components and accessories, to establish and operate motor garages, water tanks to provide services of repairing, cleaning washing, maintaining vehicles, to establish a fire safety system and to do, undertake carry on all other activities for establishment and running of Transport Terminus, own transportation system. To set up, develop, control and sale office complex, shop, Market Complex, Residential Complex, Weigh Bridge, Communication System, Conference Hall,

Electrical Station, Cold Storage, Ice Plant, Cinema or VDO Hall Hotel, Restaurants, Lodge, Dhaba, Godown, Medical Unit, Nursing Home, Hospital, Health Club either independently joint venture with government or Semi-Govt or any collaboration with any Authority.

- 5. To set up construct build establish, undertake acquire, own, operate, renovate, maintain, keep and run weigh bridge, weigh scale, cold storages, godowns, warehouses, refrigeration houses etc for storing, warehousing, keeping, preserving and commercializing goods and articles of any description and to establish communication centre provide facilities of telephones, STD, Fax, telex, Post Office, Banking etc.
- 6. To carry on the business of constructing and set up of restaurant, hotel or other lodging and boarding place, and to construct and establish cafe, beer, liquor stores, refreshment rooms, coffee shops, other amusement places and to operate and run them for the purpose incidental or ancillary to carrying of such businesses.
- 7. To develop improve, pull down, repair, renovate work, built, plan, layout, sell, transfer, mortgage, charge, assign, let out, sub lease of all types of land, plots, buildings, hereditaments, bungalows, quarters, offices, flats, warehouse, godowns, shops, stalls, markets, roads, bridges, forests and estates.
- 8. To purchase, lease, exchange or otherwise acquire land, building and other immovable properties of any type of description and rights connected with the land and turn the same into account in any manner whatsoever, and in particular by preparing building sites, opening road and by constructing, altering, improving, decorating, furnishing and maintaining offices, flats, houses, factories, warehouses, shops, building any by connecting or sub dividing properties and by leasing or disposing off the same and to acquire erasing firms/companies carrying on the similar type of business.
- 9. \*\*To undertake projects, activities or works of creation, up-gradation, renovation, improvement, maintenance, repair, modernization, modification, replacement, augmentation, etc. related to generation, transmission, distribution, or supply of power of any form including power from sources of renewable energy.
- 10. To carry on all or any of the business of producers, manufacturers, generators, suppliers, distributors, transformers, converters, transmitters, processors, developers, storers, procurers, carriers and dealers in electricity, all form of energy and any such products and by-products derived from such business including without limitation, steam, fuels, ash, conversion of ash into bricks and any products derived from or connected with any other form of energy, including, without limitation to conventional sources such as heat, thermal, hydel and/or from non-conventional sources such as tidal wave, wind, solar, geothermal, biological, biogas and coal bed methane.
- 11.\*\*To carry on the business as manufacturers, exporters, importers, contractors, sub-contractors, sellers, buyers and agents for wind mills and components and parts including Rotor Blades, braking systems, tower, nacelle, control unit, generators.
- 12. To carry on in India or elsewhere the business to generate, receive, produce, improve, buy, sell, resell, acquire, use, transmit, accumulate, employ, distribute, develop, handle, protect, supply and to act as agent, broker, representative, consultant, collaborator, or otherwise to deal in electric power in all its branches/offices at such place or places as may be permitted by appropriate authorities by establishment of thermal power plants, hydraulic power plants, wind power plants, solar power plants and other power plants based on any source of energy as may be developed or invented in future including to acquire licenses, concessions or facilities from government authorities for aforesaid activities.

# B. MATTERS WHICH ARE NECESSARY FOR FURTHERANCE OF THE OBJECTS SPECIFIED IN CLAUSE III (A) ARE:

- To enter into agreement for financial, managerial and/or technical collaboration, for any of the objects of the Company with any Indian or foreign agency, individual, firm, company or Government undertaking either in India or abroad.
- To cause the Company to be recognized in any foreign country or place and to open branches in India or outside for the purpose of the Company.
- To construct and develop residential or industrial colonies or general advancement of the employees of the company and also for letting out and selling on instalment basis.
- 4. To enter into partnership or inter any arrangement for sharing profits, union of interest, joint venture or reciprocal interest with any person, firm or company carrying on or engaged in or engaged in any business, which this company is authorized to carry on.
- To acquire and undertake by outright purchase or on lease the whole or any part of the business, properly and liabilities of any person or company or firm carrying business which is directly or indirectly beneficial to the company.
- To draw, make, accept endorse, execute and discount promissory notes, cheques, bills of exchange, hundies and other negotiable and transferable instruments in connection with company's business.
- 7. To acquire by outright purchase or transfer or license or rights to manufacturers or dealing from any ether individual firm or company or companies and also to apply for carrying out objects of the company and to apply for any license or its surrender.
- 8. To enter into any Scheme of Amalgamation or Arrangement for Merger, Demerger, hiving off or other forms of corporate restructuring with any other company, body corporate, firm or legal person or to enter into partnership or any arrangement for sharing profits, union of interest, co-operation, joint venture or reciprocal rights with any person or association of persons or companies having objects altogether or in part similar to those of the company or with shareholders or creditors of the company and/ or of any other company.
- To establish any branch in India and elsewhere and regulate and discontinue the same.
- 10.To establish, promote and assist any company or companies for purpose of furthering the objects of this Company.
- 11. To obtain from any Government or authority such rights, privileges and concessions, which the company may think desirable to obtain and to carry out, exercise and comply with any such arrangements rights privileges and concessions.
- 12. To accumulate capital for any of the purpose of the Company and to appropriate the Company's assets for specific purposes and to hold shares and securities of any other firms/companies or corporate body or Government.

- 13. To issue shares and debentures of the Company at par or at premium or at a discount and to sell or dispose of the undertaking of the Company or any part thereof for such considerations as the Company may think fit.
- 14. To remunerate any person or company and pay commission or brokerage in cash or otherwise whatsoever, for services to be rendered for the Company.
- 15. Subject to the approval of Shareholders pursuant to Section 180 of the Companies Act 2013, to sell, dispose of or transfer any of the business, property and undertaking of the company of any part thereof for any consideration, which the company may deem fit to accept.
- 16. To accept stock, share or debentures, mortgage debentures, of other company in payment or part payment for any service rendered or for any sale made to or debt owing from such company.
- 17. To enter into contract with any person or company or firm giving or taking partial or sole and exclusive right to supply by or to the company with the articles or commodities used or sold by the company on such terms and conditions and for such period or periods as may be determined from time to time.
- 18. To enter into my arrangement with any Central, State of Foreign Government or public body or person or authority or with any private individual that may seem conducive to the company's object or any of them and to obtain from any such Government Authority, person, public body and private individual, any concessions, grants, decrees, rights charters, contracts, licenses powers and privileges whatsoever which may seem to the company capable of being turned to account of which the Company may think directly or indirectly conductive to any of the objects or capable of being carried on in connection with business and to work develop carry out exercise and turn to account the same.
- 19. Subject to the relevant provisions of the Companies Act, 2013, to borrow raise of secure the payment of money in such manner as the Company shall think fit either by the issue of debentures, debenture stocks, perpetual or otherwise Bank loans etc. hypothecation of stocks etc, mortgage of any other securities charged or based upon the undertaking of the company, both present and future including the uncalled capital of the Company or without any such security and upon such security and upon such terms as to priority otherwise and to borrow money in such manner as the directors shall think fit.
- 20. To accept as a gift or as an award from Government or Semi Government bodies, property, movable or immovable in or outside India, stock, debentures, securities assigning of insurance policies or in cash or shares from or to the individuals or firms or companies whose objects may be same or different in appreciation of the service rendered or otherwise.
- 21.To lend money to such persons or companies on such terms as may seem expedient and in particular to customers and others having dealings with the Company and to guarantee the performance of contracts by such persons or companies subject to the Banking Regulations Act, 1949.
- 22. To establish, support or aid in the establishment and support of associations, institutions, funds trusts and conveniences calculated to benefit employees or ex-employees (including Directors and Ex-directors) of the Company (or its predecessors in business or the dependants or connections of such persons) to grant pensions and allowances, gratuities, bonuses and annuities and to make payment towards insurance and to subscribe or guarantee money for charitable or benevolent objects or for any exhibition or for any public, general or useful objects subject to the provisions of Section 182 of the Companies Act, 2013.
- 23.To apply for purchase or otherwise acquire, protect, and prolong and renew whether in India or elsewhere any patents, patent right, trade-marks, designs, licences, protections, concessions and the like conferring any exclusive or non-exclusive or limited right to use any secret or other information as to any invention process or privilege which may seem capable of being used for any of the purpose of the Company or the

acquisition of which may seem calculated directly or indirectly to benefit the company and to use, exercise, develop, manufacture under or grant licences or privileges in respect of, or otherwise turn to account the property, rights and information so acquired and to carry on any business in any way connected therewith.

- 24. To acquire from, incorporate or promote any company, firm or companies, whether in India or in foreign country, having amongst its or their objects the acquisition of all or any of the assets or control, management or development of the Company, firm or any other objects or object which in the opinion of the Company could or might rightly or indirectly assist the Company in the management of its business or the development of its properties or otherwise prove advantageous to the Company and to pay all or any of the costs and expenses incurred in connection with any such promotion or incorporation and to remunerate any person or company in any manner it shall think fit for services rendered or to be rendered in obtaining subscriptions for or placing or assisting to place or to obtain subscriptions for guaranteeing the subscriptions of or placing of any shares in the capital of the Company or any bonds, debentures, obligations or securities of the Company or any stocks, shares, bonds, debentures, obligations or securities of any other Company held or owned by the Company or in which the Company may have an interest in or about the promotion or formation of any other company in which the Company may have an interest.
- 25. To provide for the welfare of the employees, ex-employees, directors and ex-directors of the company or its predecessors in business or the family members, dependants or connections of such persons by building or contributing to the building of houses, dwelling or quarters or by grants or money, pensions, gratuities, allowances payment towards Insurance, houses, profit showing bonuses or benefits of any other payments or by establishing, supporting from time to time, subscribing contributing or siding in the establishment and support of association, institutions funds including provident funds, trust, profit sharing or other schemes and conveniences and by providing or subscribing or contributing towards the place of instructions and recreation, hospitals, and dispensaries, medical and other attendances as the company shall think fit.
- 26.To undertake and for that purpose to appoint and remunerate any directors, officers or other experts and agents and also to sell or otherwise dispose of any of the property or investments of the company not in the nature of stock in trade and also to employ and/otherwise engage experts to investigate and examine into the condition, prospects, value, character and circumstances, of any business concerns and undertaking and generally of any assets, property or nights.
- 27.To act as import and export houses, advisers for import and export houses, advisers for import and export indenting Agents, sellers and purchasers of licences, release orders and quotas entitlements.
- 28.To carry on the business of builders, constructions, dealers in and manufacturers of prefabricated and precast houses, buildings and erections and materials, tools, implements, machinery andmetal work in connection therewith or incidental thereto and to carry on any other business that is customarily usually and conveniently carried on therewith.
- 29.To undertake, carryout, promote and sponsor any activity for publication of any books, literature, newspapers etc. or for organizing lectures or for merit awards, scholarships, loans or any other assistants to deserving student or other scholars or persons to enable them to prosecute their studies or academic pursuits or researchers or for establishing, conducting or assisting any institution, fund, trust etc. having any one of the aforesaid objects by giving donations, or in any other manner.
- 30.To lend money and negotiate with or without security whether of movable and immovable properties to such companies' firms or persons on such conditions as may seem expedient and to guarantee the performance of contracts by any person, company or firm provided that the Company shall not carry on the business of banking.

- 31. To carry on in all their aspects the business of hire purchase or general finance investment trust, finance brokers.

- 33.To buy, sell import, export, manufacture, process, convert, grind, treat and deal in merchandise commodities and articles of all kinds and to carry on business as traders, importers and exporters and to act as purchasing, selling or commission agents.
- 34. To carry on business and to act as General Contractor and to do any construction, manufacturing, building, road making, engineering and all other kinds and descriptions whatsoever for any person firm, Company, Public body, government, Army, Navy, Railways, etc. by the Company itself or in partnership with such company or individual or persons as may be thought fit by the Directors.
- 35. To carry on the business of manufacturers of and dealers in all kinds and classes of papers board, paper, products and pulp.
- 36.To carry on the business as producers, manufacturers, processors, convertors, refiners, makers, bottles, stockists, dealers, importers, exporters, traders, retailers, agents, buyers or sellers of oxygen, acetylene, ammonia, nitrogen, hydrogen, helium and other types and kind of gases required for or used in industries, agriculture, clinics, hospitals, refrigeration, aviation, transport vehicles, space rockets and crafts, communication, objects and media power plants domestic or public lighting, heating, cooling or cooking purposes, lighters, plants producing water, chemicals or fuels, pesticide, defence or warfare establishment, horticulture, forest or plant protection and growth and other allied purposes and to service, repair, manufacture, market or deal in machinery plants, spares, cylinders, containers, gadgets appliances and accessories required for working on, using or producing any of such gases and products.

To manufacture, process, import, export, buy, sell and deal in Vanaspati oils dehydrated vegetable oils, oils made or processed from seeds, cotton seeds coconut products, of plantations, horticulture, agriculture and forests produce and oil cakes and soaps and lubricants made from such oils or as by products thereof.

To produce, manufacture, purchase, refine, prepare, process, import, export, sell and deal in cement, Portland cement, alumina cement, asbestos cement, lime and lime stone and by products thereof, cement pipes, sheets and other building materials, refractories, fire-bricks, fumace lining bricks acidic, basic and neutral, insulating boards, wall boards, plasters, motor, marblemosaic, tiles and the like.
- 41. To carry on business as timber merchants, saw mill properties and timber growers and to buy, sell grow, prepare for market, manipulate, import, export and deal intimber, teak, plywood, hardboards, fire wood and wood of all kinds and to buy, clear, plant and work timber estates.
- 42. To carry on the business of manufacturers, fabricators, processors, products, growers, makers, importers, exporters, buyers, sellers, suppliers, stockists, agents, merchants, distributors and concessionaires of and dealers in flour, cakes, pastry, cornflakes, bread biscuits, chocolates, confectionery, sweet, fruit drops, sugar, glucose, chewing gums, milk, cream, ice, ice cream, aerated or mineral water, fruit juices, wines, liquors and other alcoholic drinks and fermentation products, canned fruit products, milk and malted food, cigarettes cigars, protein foods, maize products, butter, ghee, cheese and other dairy products, pickles, jams, jellies, sausages, cider, poultry and eggs, pulses, spices oils, powder and condenses milk, honey, fresh and dehydrated vegetables, coffee, tea, cocoa seeds, processed seeds, concentrate for cattle or poultry feed, fruits and all kind processes foods as well as materials required or used for preparation of food articles.
- 43. To carry on the business as travel agents, tourist and cargo carriers by road, air, sea or any other mode of transport and to carry on all allied business and activities to the traveling and tourist business.
- 44.To carry on business, as manufacturers, producers, dealers, processors, importers, exporters, stockists, agents, brokers, traders, retailers of all kinds of paper including writing, printing, wrapping and tissue, newsprint paper for packing including corrugated and kraft paper, synthetic papers, paper board and straw board, and all kinds of pulp whether mechanical or chemical including dissolving pulp and also to carry on business as printers and publishers including of newspapers, books and journals.
- 45.To manufacture, produce, buy, sell, import, stock and deal in machines tools, grinding machines automatic lathes, drilling machines, planning machines Plano grinders, machinery of every description, precision, tools cutting and small tools, fasteners, electric motors, electrical equipment, cables, wires, switch-gears, flame and drip proof meters, electric fans, cookers and flasks, Gramophone, including record players and records, other domestic appliances, regulators of all types, electric kilowatt hour meters, magnets, industrial jewels ammeters, volt meters, and other type of measuring instruments, electrical or non-electric die castings, screws, nuts and bolts, transformers of all types, circuit brakers, hoists elevators, gears, trolleys and coaches, winches, air compressors, transformers and switchgears, welders, refrigerators, domestic washing machines, television and wireless apparatus including radio receiver and transmitters, microwave components, radar equipment's, valves, resistors, electronic instruments conductors, magnetic materials, transistors and allied sewing machines, watches and clocks, tape recorders, household appliances and components parts thereof.
- 46.To carry on the business of manufacturers and dealers in air-conditioning and refrigeration thermal and hydro power generation equipment, equipment's, consumer and domestic appliances, radios and transistors, electronic equipment including television and computers, oxygen and acetylene electrodes including graphite electrodes weighing scales, cement refractories, batteries, agricultural equipment, thermometers, flashlights, detonators and explosives, Hume and cement pipes, asbestors starch and by-products wire ropes, linoleum, glass, calculators, typewriters and all forms of office equipment's, magnets, gauges and precision instruments, conducts, rectifiers, capacitors, meters, matches, grinding and abrasive equipment, potteries, tiles and ceramics, lighting equipment, oils, manures or any one or more of such business in all or any of their respective branches.

- 47. To grow, cultivate, manufacture, treat, cure, blend process, buy, sell or deal in tea or coffee in various forms.
- 48.To carry on business as manufacturers, distributors, importers, exporters, agents and generally deal in all kinds of leather items and things made of leather and leather goods and chemicals used for manufacture of leather products.
- 49.To carry on the business of chemical engineers', chemical manufacturers, chemists, analysts research chemists, importers and manufacturers of and dealers in pharmaceutical, medical, chemical, industrial and other products and articles, compounds, cements, oils, paints vanished drugs, medicines, dye-wares and makers of and dealers in patent, medicines, surgical and scientific apparatus and materials.

all articles and things used in manufacture, construction, erection maintenance and working thereof in connection therewith in anyway whatsoever. To repair the same and their machinery and apparatus.

- 57. To manufacture, process, buy, sell, import and deal in all kinds of machinery food products, seeds,patent and licences all kinds of fertilizers, lime mineral products and stock-feeds.
- 58.To carry on the business of founders of ferrous and non-ferrous metals, sheet workers, mechanical, structural, electrical and metallurgical engineers, to carry on the work of cast iron foundry for the manufacture of all types of pipes and pipe-fittings, water-reservoirs, drainage requisites including manhole frames and covers, granting and loaders, cast iron sanitary appliance and fitting including flushing cisterns, bath-tubes, wash-basins, cast iron, building requisites including railing, spiral stairs, ladders, ventilators, ornamental window-frames, pillars agricultural implements including choppers, ploughs, cast iron railway castings including sleepers, fish plates, wheels and other fittings household requisites, and utensils, including cooking pans, containers, coal mining and engineering requisites including pinions, tube wheels, pump-parts and other general and special castings.

- 77. To deal in scraps or by products arising out of the manufacturing process and also to deal in, export and import in any such product.
