Limited Review Report

To

- 1. We have reviewed the accompanying statement of unaudited financial results ("the Statement") of RDB Infrastructure and Power Limited (Formerly known as RDB Realty & Infrastructure Limited) ("the Company"), for the quarter ended June 30, 2025.
- 2. This Statement, which is the responsibility of the Company's Management and approved by the Board of Directors, has been prepared in accordance with the recognition and measurement principles laid down in Indian Accounting Standard 34 "Interim Financial Reporting" ("Ind AS 34"), prescribed under Section 133 of the Companies Act, 2013, and other accounting principles generally accepted in India. Our responsibility is to issue a report on the Statement based on our review.
- 3. We conducted our review of the Statement in accordance with the Standard on Review Engagements (SRE) 2410 "Review of Interim Financial Information Performed by the Independent Auditor of the Entity", issued by the Institute of Chartered Accountants of India. This standard requires that we plan and perform the review to obtain moderate assurance as to whether the financial statements are free of material misstatement. A review is limited primarily to inquiries of company personnel and analytical procedures applied to financial data and thus provides less assurance than an audit. We have not performed an audit and accordingly, we do not express an audit opinion.
- 4. Attention is drawn to Note 4 of the accompanying Statement, which describes that the Company has recognized income of Anjana project as revenue from operations during the quarter ended 30 June 2025. In our view, only the differential amount, that is profit should have been recognized under "Other Income" as the transaction does not represent income arising from the Company's ordinary activities.
- 5. Based on our review conducted as above and subject to the matter mentioned in paragraph 4 above, nothing has come to our attention that causes us to believe that the accompanying statement of unaudited financial results prepared in accordance with applicable accounting standards and other recognized accounting practices and policies has not disclosed the information required to be disclosed in terms of Regulation 33 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 including the manner in which it is to be disclosed, or that it contains any material misstatement.
